

## **MILLER'S MERRY MANOR**

Miller's Merry Manor, located in Hope, is a fully-certified Medicaid facility. All beds at Miller's are "dual certified" for residents on both Medicare and Medicaid. Miller's operates more than thirty other facilities throughout Indiana, and each is 100% employee owned. Other area locations include Rushville, Mooresville, and Sullivan. They have a total capacity of seventy-one residents and generally have openings for new residents depending on the room preference. Tours of the facility for potential residents and their families can be scheduled anytime day or night.

Miller's does not have set criteria for who may be admitted, but they will perform an assessment of any potential resident to determine if they are able to meet the resident's needs. They have the capacity to support patients in need of wound VACs, bariatric services, and who are non-ambulatory. Miller's has a Medicare certified rehabilitation center that has occupational, physical, and speech therapies. Miller's can care for patients with Alzheimer's Disease and dementia but they do not have a dedicated Alzheimer's/dementia unit.

All rooms at Miller's have a similar layout, and the facility is divided into long-term and short-term rooms. All rooms come equipped with beds and standard furnishings. Long-term residents are encouraged to decorate the rooms and make them more home-like. Residents have the option of either a private or shared suite, and prices vary accordingly. There is also a hospice/family suite that is available to shared room residents and their families who need privacy during difficult times.

The medical staff during regular hours consists of three registered nurses (RNs) and six Certified Nursing Assistants (CNAs). On average, the resident to CNA ratio is about one to ten. There are also four rounding medical doctors supervised by a medical director. Miller's operates an in-house therapy service known as Theracare and has pharmaceutical services available on-site.

Miller's daily rate includes three meals a day and structured snacks between meals. The meals are served restaurant-style, and each resident is given a menu they can fill out with the day's food options. The snacks are served to the residents in their room and residents can also bring in their own snacks. Miller's coordinates activities including church service, movies, excursions to dinner or area stores, weekly exercise programs, and haircare services. Transportation is provided to appointments and is free of charge to the residents.

Miller's offers options for temporary or respite care for those who need a break from taking care of a loved one. The respite stay is paid daily and adult daycare services are even offered by the hour. Respite care is available for stays up to thirty days. Adult daycare is available throughout the day and daycare residents will be provided with a meal.
